Alamo Hills Church, just outside of San Antonio, has Matt. 28:16-20 as its theme verses. “Go and make disciples,” included in Jesus’ important instructions, make these verses especially appropriate. This congregation is meeting in a movie theater on Sunday mornings, and then meets people wherever they are the rest of the week.

Alamo Hills has been in the planning and “working toward” stages for two years, but officially began as a congregation in September 2018. They are blessed to be based in two movie theater rooms. One is used for worship and “whole-group” time, and the other room, along with the outside corridor, is used for children and youth activities.

Alamo Hills is one of two congregations within the Alamo Ranch community of San Antonio, which has a

The phrase that the leadership team uses to remain focused and moving forward is “Guide all peo-



ple into a transforming relationship with Jesus Christ.” What a wonderful goal for all of us in our daily walk with God. It is an honor and privilege that we can partner with Alamo Hills Church by giving our mites to reach out.

## Don't forget bylaw review

Whether you represent a society, zone or district, your bylaws are an important part of your organization. They should be reviewed every five years.

Here are some guidelines:

- ▶ Articles on name, object, membership and parliamentary authority must conform to national bylaws.
- ▶ Be sure to use current terms. (Use of the *LWML Style Guidelines* is recommended as titles and committees change often.) Be careful of wording and correct punctuation for clarity.
- ▶ Write flexible bylaws. Be brief;

use the barebones bylaws as a guide.

- ▶ Use standing rules for items that may change frequently, such as committees, meeting information, etc.

Bylaws need to live and breathe, reflecting the group's thinking and current practice.

Remember that bylaws amendments must be approved by the LWML District Structure Committee before they can be adopted and implemented by your zone or society.

Always feel free to call upon me for help. I am excited to serve the district for my first term in this capacity and am so blessed!
